The pilot is Miroslaw Zrncevic, Chief Test and Development Driver at Bugatti Rimac.

The winner will be expected on 5 October 2022 at 9am at the Porsche Centre Knokke-Heist (Natiënlaan 144, 8300 Knokke-Heist) with Bernard Van Bellingen. From there, the winner will drive together with Mr. Van Bellingen to the location of the test drive.
